### **Items Needed For Class:**

- treats and/or toys to motivate your puppy to learn (examples: favorite stuffed toy or ball, small semi-moist treats, freeze-dried liver, cheese, hot dog)

- positive attitude

- collar, head halter, or harness and leash

It is helpful if you bring your dog to class hungry (e.g., before dinner)

Choke, prong, or pinch collars are not allowed.

**Please do not attend class if your dog is exhibiting any signs of unthriftiness, including vomiting, diarrhea, lethargy or poor appetite.** This rule maintains a safe environment for all attending puppies. Remember that you can attend a make-up class at a later date if you miss class as long as your puppy will be less than 20 weeks old at the time of the make-up class.

# Responsibility/Waiver Form for Puppy Kindergarten at Southwest Veterinary Hospital

## CONDITIONS OF ENROLLMENT

This Form and the Puppy Kindergarten Registration Form must be completed, signed and received at least 3 days before the first class.

## CANCELLATION/REFUND POLICY

The \$60 tuition fee or \$15 single class fee is **non-refundable** unless your dog is unable to attend classes due to death or hospitalization.

## ATTENDANCE POLICY

The \$60 tuition fee covers six classes, which are best attended consecutively. Missed classes can be made-up at a later time, but class attendance is closed to puppies 20 weeks (5 months) old or older. No refund of fees for missed classes if a puppy exceeds the age of 20 weeks.

## AGREEMENT TO HOLD HARMLESS, WAIVER AND ASSUMPTION OF RISK

This Agreement between \_\_\_\_\_ (hereinafter referred to as "Client") and Anika Colopy acting as agent for Southwest Veterinary Hospital (hereinafter known as "Trainer") pertains to the following:

I (the Client) understand that participation in a dog training session is not without risk to myself, members of my family or guests who may attend, or my dog. I acknowledge the fact that puppies attending the class are inexperienced and may be difficult to control at times even when handled with the greatest of care.

I (Client) hereby waive and release Southwest Veterinary Hospital its employees, officers, members and agents from any and all liability of any nature, for illness, or damage which I or my dog may suffer, including specifically, but without limitation, any injury or damage resulting from the action of any dogs, or damage or injury from any other cause, and I expressly assume the risk of such damage or injury while attending any training sessions, or any other function at Southwest Veterinary Hospital, or while on the grounds or the surrounding area thereto.

This Agreement is binding upon Client, spouse or representative of Client, and children of Client. This Agreement supersedes all prior discussions, representations, warranties and agreements of the parties, and expresses the entire agreement between Client and Trainer regarding the matters described above. The parties confirm that, except for that which is specifically written in this Agreement, no promises, representations or oral understandings have been made with regard to Dog or anything else. Without limiting the generality of the foregoing, Client acknowledges that Trainer has not represented, promised, guaranteed or warranted that Dog will never bite, that Dog will not be dangerous or vicious in the future, that Dog will not exhibit other behavioral problems, or that the results of the training will last for any particular amount of time. This Agreement may be amended only by a written instrument signed by both Client and Trainer.

It is further understood that I need to meet Southwest Veterinary Hospital's vaccination and health requirements for my puppy to attend class. I hereby verify that:

- My dog has been a member of my household for at least 14 days
- My dog is on a veterinarian approved flea preventative (e.g., Frontline, Advantage products, Revolution, Comfortis, Program, Capstar)
- My dog has had the most recent fecal examination testing result negative for intestinal parasites
- My dog has acquired his/her most recent DHPP (Distemper, Hepatitis, Parvovirus, Parainfluenza) vaccine at either Southwest Veterinary Hospital or Stiern Veterinary Hospital 14 days prior to attending class. I also agree to continue on the vaccination schedule recommended by my veterinarian while my dog is attending puppy class.
- My dog is apparently healthy with no signs of vomiting, diarrhea, lethargy, or poor appetite

I further understand that any violation of this agreement could lead to the immediate termination of my involvement in the event or activity (including being asked to leave the premises) without refund of any monies paid for that event or activity. I agree that I may be dismissed from any and all classes at any time, with or without cause, and in such event no Initial portion(s) of my prepaid training fees will be refunded. At Trainer's sole election, Trainer's duties hereunder shall terminate if in Trainer's sole judgment Dog is dangerous or vicious to Trainer or any other person or animal, or interferes with the training of other dogs.

**I have read this agreement carefully, fully understand its contents, and am voluntarily signing below. I am aware that this is a release of all liability and a binding contract.**
